Voter Registration closes: July 4, 2022 at Midnight

First day to file: March 5, 2022

Last day to file: April 4, 2022 at 5:00 p.m.

CANDIDATE NOMINATION PETITIONS “NOMINATION OTHER THAN BY PRIMARY” / “INDEPENDENT”

First day to file: March 5, 2022

Last day to file: April 4, 2022 at 5:00 p.m.

CANDIDATE 10-DAY CHALLENGE PERIOD

Primary Election: April 5, 2022 – April 18, 2022 at 5:00 p.m.

WRITE-IN CANDIDATES

Deadline to file is 105 days out for elections that CAN be cancelled (including precinct committeemen), 40 days out for elections that CANNOT be cancelled.

Primary Election: ****(105) April 19, 2022 at 5:00 p.m.**
 (40) June 23, 2022 at 5:00 p.m.

Early Voting Begins: July 6, 2022 (27 days prior to Election Day)

Last day to request a ballot by mail: July 22, 2022 at 5:00 p.m.

Last day to vote early in person (at an early voting location): July 29, 2022 at 5:00 p.m.

GENERAL ELECTION – November 8, 2022

Voter Registration closes: October 10, 2022 at Midnight

CANDIDATE NOMINATION PETITIONS (NONPARTISAN/GENERAL ELECTION ONLY)

First day to file: June 11, 2022

Last day to file: July 11, 2022 at 5:00 p.m.

Early Voting Begins: October 12, 2022 (27 days prior to election day)

Last day to request a ballot by mail: October 28, 2022 at 5:00 p.m.

Last day to vote early in person (at an early voting location): November 4, 2022 at 5:00 p.m.

CANDIDATE 10-DAY CHALLENGE PERIOD

General Election: July 12, 2022 – July 25, 2022 at 5:00 p.m.

WRITE-IN CANDIDATES

Deadline to file is 105 days out for elections that CAN be cancelled, 40 days out for elections that CANNOT be cancelled.

General Election: ****(105) July 26, 2022 at 5:00 p.m.**
 (40) September 29, 2022 at 5:00 p.m.

First day to file for retention: August 10, 2022

Last day to file for retention: September 9, 2022 at 5:00 p.m.
