First day to file: May 2, 2016

Last day to file: June 1, 2016 at 5 p.m.

CANDIDATE NOMINATION PETITIONS "NOMINATION OTHER THAN BY PRIMARY" / "INDEPENDENT"

First day to file: May 2, 2016

Last day to file: June 1, 2016 at 5 p.m.

Early Voting Begins: August 3, 2016 (27 days prior to Election Day)

Last day to request a ballot by mail: August 19, 2016 at 5 p.m.

Last day to vote early (at an early voting location): August 26, 2016 at 5 p.m.

GENERAL ELECTION

November 8, 2016

Registration closes October 10, 2016 at midnight

CANDIDATE NOMINATION PETITIONS (NONPARTISAN/GENERAL ELECTION ONLY)

First day to file: July 11, 2016

Last day to file: August 10, 2016 at 5 p.m.

Early Voting Begins: October 12, 2016 (27 days prior to election day)

Last day to request a ballot by mail: October 28, 2016 at 5 p.m.

Last day to vote early (at an early voting location): November 4, 2016 at 5 p.m.

CANDIDATE 10-DAY CHALLENGE PERIOD

Primary Election: June 2, 2016 – June 15, 2016 at 5 p.m.

General Election: August 11, 2016 – August 24, 2016 at 5 p.m.

WRITE-IN CANDIDATES

**(76 days out for elections that CAN be cancelled (including precinct committeemen),
40 days out for elections that CANNOT be cancelled)**

Primary Election: (76) June 15, 2016 at 5 p.m.

(40) July 21, 2016 at 5 p.m.

General Election: (76) August 24, 2016 at 5 p.m.

(40) September 29, 2016 at 5 p.m.

First day to file for retention: July 11, 2016

Last day to file for retention: September 9, 2016 at 5 p.m.
