## **PRIMARY ELECTION – August 25, 2020**

Voter Registration closes: July 27, 2020 at Midnight

### **CANDIDATE NOMINATION PETITIONS (PARTISAN / PRIMARY ELECTION)**

First day to file: April 27, 2020

Last day to file: May 27, 2020 at 5:00 p.m.

### **CANDIDATE NOMINATION PETITIONS "NOMINATION OTHER THAN BY PRIMARY" / "INDEPENDENT"**

First day to file: April 27, 2020

Last day to file: May 27, 2018 at 5:00 p.m.

### **CANDIDATE 10-DAY CHALLENGE PERIOD**

Primary Election: May 28, 2020 – June 10, 2020 at 5:00 p.m.

### **WRITE-IN CANDIDATES**

**Deadline to file is 76 days out for elections that CAN be cancelled (including precinct committeemen), 40 days out for elections that CANNOT be cancelled.**

Primary Election: (76) June 10, 2020 at 5:00 p.m.

(40) July 16, 2020 at 5:00 p.m.

**Early Voting Begins:** July 29, 2020 (27 days prior to Election Day)

Last day to request a ballot by mail: August 14, 2020 at 5:00 p.m.

Last day to vote early in person (at an early voting location): August 21, 2020 at 5:00 p.m.

## **GENERAL ELECTION – November 3, 2020**

Voter Registration closes: October 5, 2020 at Midnight

### **CANDIDATE NOMINATION PETITIONS (NONPARTISAN/GENERAL ELECTION ONLY)**

First day to file: July 6, 2020

Last day to file: August 5, 2020 at 5:00 p.m.

**Early Voting Begins:** October 7, 2020 (27 days prior to election day)

Last day to request a ballot by mail: October 23, 2020 at 5:00 p.m.

Last day to vote early in person (at an early voting location): October 30, 2020 at 5:00 p.m.

### **CANDIDATE 10-DAY CHALLENGE PERIOD**

General Election: August 6, 2020 – August 19, 2020 at 5:00 p.m.

### **WRITE-IN CANDIDATES**

**Deadline to file is 76 days out for elections that CAN be cancelled, 40 days out for elections that CANNOT be cancelled.**

General Election: (76) August 19, 2020 at 5:00 p.m.

(40) September 24, 2020 at 5:00 p.m.

### **SUPREME / APPELLATE / SUPERIOR COURT - JUSTICES AND JUDGES**

First day to file for retention: August 5, 2020

Last day to file for retention: September 4, 2020 at 5:00 p.m.
