



16-241. Presidential preference election; conduct of election

A. A presidential preference election shall be held on the fourth Tuesday in February of each year in which the president of the United States is elected to give qualified electors the opportunity to express their preference for the presidential candidate of the political party indicated as their preference by the record of their registration. No other election may appear on the same ballot as the presidential preference election.

Misinformation #4



Voters did not receive notification of the election or their polling place location.



Notification Sent

- All registered Democrats and Republicans were mailed a sample ballot listing their polling place.
- Voters who were not registered to either party DID NOT get notification as they were not eligible to vote
- We had some polling place changes and those effected voters received a polling place change card



Notification Read?



Caller on 2/8 wished to complain to Maricopa County Elections about rude and intolerable treatment by election pollworker while trying to vote on Feb 5. When she walked up to registration table, she was asked for her “yellow card.” She said, “What yellow card?” The worker told her she had to show the worker her yellow HOA card to prove that her dues were paid in order to vote there. The worker told her she could vote somewhere else, just not there without the yellow dues card!!! Voter was totally embarrassed and left without voting after such treatment.

I returned the voters call to verify the information. Voter verified she was not current on her voter registration, and went to Dreamland Community Center (320 N 55th Place in Mesa) because that is where she registered when she first moved there. There was an election in progress when she arrived and tried to vote.



Dreamland Community Center **WAS NOT A POLLING PLACE** for the PPE—they were conducting their **HOA ELECTION**.

Yet, this was somehow a reflection on the County...

We took 52,150 calls on in the 3 weeks before the election from voters.

Permanent Early Voting List



- End of Voter Registration there were 420,996 Dem's and Rep's on the Permanent Early Voting List.
- 354,835 returned their ballots with signatures so that they could be counted
- 84% *TURNOUT!!***

- Not all early voters were on the PEVL
- 13,301 sent in an early ballot request just for the PPE

- Not all voters remembered signing up for the PEVL.
- Some thought that their official ballot was a sample ballot.
- Some moved and did not get a ballot in the mail.
- Those voters went to the polls
- Of the 13,167 Early Voters who cast provisional ballots 12,565 were on the PEVL

We have been registered Republicans for 10 years and have not moved, etc. We want to come to the polls and vote. Please fix this mess!!!Now, I see in the paper where those ballots haven't been counted. I want my vote counted the day I vote.

Suggestions: Yes, Don't send out any early ballots that ARE NOT requested. Please fix this before the fall election. We had to get out of the regular line and get in the "provisional line" when we had done everything required by law to vote. It was embarrassing and time consuming!!! Please--somebody phone and assure us this won't happen again or explain or something!!!!”

Only eligible voters were printed on the roster in their applicable precinct.

Libertarians, Green, Independents, and non-party affiliated voters are STILL REGISTERED but were not printed as they were not eligible to vote.

If I am registered in Phoenix I will not appear in a roster in Mesa or Buckeye—I am not an eligible voter in their elections.

In an unprecedented move we had 2 observers shop themselves to both political parties having an election but could not gain permissible access to our ballot tabulation center from either the Democrats nor the Republicans (they both already had observers in place).

These individuals eventually found sponsorship with the Libertarian Party (who declined participation in the “taxpayer financed candidate publicity event known as the Presidential Preference Election”—see letter, slide 6).

The courts determined this was admissible.









AUDIT:

Per statute we do a hand-count audit of 1% (or 5000 whichever is less) of the Early Ballots Cast and 2% of the precincts (8 precinct consolidations for this election).

For the Presidential Preference Election we opted to not only audit the race chosen by the party chairs in the 8 precincts, but in 2 of the precinct to also audit the other party's ballots.







On one board they were 1 ballot off. Our warehouse staff retrieved the equipment from the polling place and found the missing ballot still in the ballot box stuck to the inside of the box by static electricity. The boardworkers missed it when removing the ballots at the end of the night.

Another board was 100% when auditing the Democratic ballots. They were one of the precincts which also audited the Republican ballots. They found that they were one ballot short, but all of the votes for the candidates came out to the correct total.

Warehouse staff retrieved the equipment but found no stray ballot.

The auditors counted the ballots for a third time and came up with the correct total.




In one precinct we opened the bag to find an empty printer. The boardworkers had removed the tape and sent it along with the optical scan tape and memory pack.

We contacted our BTC room, they located the items for that precinct and found the tape. It was delivered to the audit.

One vote had been cast according to the paper record which coincided exactly with the report from that precinct.



- We have added new categories to our provisional tracking process to capture those voters who vote a provisional ballot conditional upon coming back with sufficient ID.
- Some voters returned with ID on Election Day or post Election Day and their vote counted.






Conditional Provisional Analysis



A cursory analysis was done of the Conditional Provisional ballots to get a general indication of the impact of the ID requirements. This was by no means a scientific study, but rather an elementary evaluation based on the following criteria:

- **Gender:** first names were reviewed and gender assigned via judgment call of traditional name assignation (ie: Kerr*i* deemed female, Ton*y* deemed male).
- **Hispanic Surname:** last names compared to the 1980's Census list of Hispanic Surnames which is the list recommended by the Department of Justice
- **Age:** voters with DOB on file or provided were reviewed, unregistered voters without that information included were not part of analysis.
- **Not all voters could be categorized. The total numbers may not match official canvass returns for this reason.**
