

Must be a resident of Arizona and the county in which you are registering



Felony Convictions

First time felons have their rights restored upon completion of their probationary period and satisfying restitution requirements—they can then register.

Second time or multiple felonies require a restoration of civil rights by the courts after a waiting period before they are able to register.



Adjudication of Incompetency

One does not have the right to register if they have been adjudicated incompetent unless they petition to have their rights restored.




- It also dictates the taxes that you pay when questions are asked of the voters in a given district.




Staying Current Is Easy

 - By calling 602-506-1511 and having one mailed to you
 - From any of our 3 offices (MCTEC, Downtown, or Mesa)
 - By printing it off of our website (www.recorder.maricopa.gov)
 - From the Arizona Secretary of State's office
 - From any City or Town Clerk's office
 - From any of the political party offices
 - At any public assistance agency







- Party affiliation will only limit participation in the *Presidential Preference* election conducted every 4 years in February.
- This election may be called by any, or all, parties selecting their candidate for President.
- It may be only a single party participating, but it can be more.

Open Primary




- The Primary Election held in August is an entirely different matter.
- **ALL VOTERS CAN PARTICIPATE IN THE AUGUST PRIMARY** —regardless of party affiliation.
- If you have registered to a party that is the party's ballot you receive.
- If you are not registered to one of the recognized parties you may select one (***this DOES NOT change how you are registered, just provides you with that party's ballot***).






Being a registered voter does NOT mean that you have the right to vote in EVERY election

Impact



Be Vigilant!

- If you complete a registration form and give it to anyone other than a Maricopa County Election Department or Arizona Secretary of State staff person ***be sure to keep your receipt***—it is the only proof you have that you registered.
- This receipt will suffice to get you registered if the 3rd party organization you gave your registration to does not turn it in...
- If you do not get your ID card within 4-6 weeks of completing the form ***contact MCED***.

The Secretary of State shall submit this amendment to the voters at the next general election as provided by Article XXI of the Arizona Constitution.</p> |

ANALYSIS BY LEGISLATIVE COUNCIL

Proposition 100 would amend the Arizona Constitution to prohibit the state or any county, city, town or other political subdivision of the state from directly or indirectly imposing any new tax, fee or other assessment on the sale, purchase, transfer or other conveyance of any interest in real property (such as homes and other real estate). This proposed measure would not affect any tax, fee or other assessment in existence prior to this year.

FISCAL IMPACT STATEMENT

State law requires the Joint Legislative Budget Committee (JLBC) Staff to prepare a summary of the fiscal impact of certain ballot measures. Proposition 100 is not estimated to have a direct state or local fiscal impact. The proposition prohibits the imposition of new fees or taxes on the sale or transfer of real property after December 31, 2007. No such new fee or tax has been enacted since that date. The level of foregone revenues cannot be predicted in advance as it would depend on the specific details of a particular tax proposal.

As an Arizona homeowner since 1974 and a current candidate for the Pima County Board of Supervisors, I strongly support this initiative to prohibit any new sales tax on our homes and property.

It's a matter of government fiscal accountability. There's no amount of money that a financially irresponsible administration cannot spend. Voters must monitor how carefully our elected officials use the dollars they've already been given. Our enormous state budget deficit and record levels of spending in Pima County in recent years make it clear that these folks don't deserve even more of our hard-earned cash.

It's common for spendthrift governments to waste money or to underfund their mandated responsibilities and then cry to taxpayers for more financing. For example, although road maintenance is a top mandate for all Arizona counties, Pima County "puts NO general fund money toward maintenance." (Arizona Daily Star, 5-18-2008) This is absurd.

Governments collect windfalls on our homes each year in the form of property taxes. Now they're contemplating additional taxation to make beleaguered taxpayers bail them out of their financial mess.

At the State of Arizona level, there is no such tax-revenue source, and any new tax-revenue source requires a super-majority of two-thirds vote by each Arizona legislative house and the Governor's signature. If the Governor vetoes any new tax-revenue bill, then the Legislature must muster a three-quarters vote in each Arizona legislative house to override the veto to enact the new tax-revenue law.

At the County-City-Local levels, which are the closest form of representative government that we have, these local representatives should not have their hands tied if future conditions require that all sources of revenue are available. Local officials feel the heat of being ousted from office when they infuriate the voters.

This proposal says, "Let's bind society's hands more, and put off-limits a potential revenue quill in our social contract quiver. Even if desperately needed, we will keep it off-limits."

In the 1970's, the State of Arizona revenue sources were relatively diversified with about 30% sales taxes, 30% income taxes, 30% federal transfer funds, and about 10% from everything else. Because of tax cuts for businesses and the wealthy during the 1990s through today, Arizona's revenues are non-diversified: 50% sales tax, 30% income tax, and 20% federal transfers.

Why are Arizona's revenue finances in horrible shape? We are dependent on the cyclical sales tax. Arizona's social contract with its citizens can only be carried out by its representatives when government has a variety of tax sources and responsible spending.

This proposal stomps on social equity and social justice by shifting the cost of government from businesses and the wealthy to middle and low income citizens. We should all shoulder our share!

Voting Materials at the Polls

- You have the right to take voting materials with you to the polls and into the booth with you to aid in the decision making process.
- You may wear election-related t-shirts, buttons, hats, etc.
- However, you *CANNOT* verbally campaign in any attempt to influence other voters. If you do so the boardworkers will ask that you leave the materials outside of the 75 foot electioneering limit.

There are a number of options for casting your ballot in Arizona

- Vote by mail
- Vote at an early voting site
- Vote via assistance from a Special Election Board
- Vote at the polls on Election Day
- Overseas voters can vote a Federal Write in Absentee Ballot (FWAB)

Early Voting Options

Early Voting Sites



- Early voting sites are available throughout the county starting 26 days before Election Day.
- All voters are eligible to vote at an early voting site.
- ID is not required to vote at an early voting site.
- Voters sign the early voting affidavit on the envelope and their signature is verified against their voter registration.


- Early voting sites close at 5:00 PM on the Friday prior to the election.
- ***EVERYONE*** in line at that time gets to vote—but no one gets in line after 5:00 PM.



Vote by mail



- All voters have the vote by mail option available as well.
- Ballots are sent out to local voters still residing in the county, to other regions of the state, across the country, and around the world.
- MCED must have a signed request from the voter for signature verification in order to send a ballot to an address other than that of the voter's registration.



Vote by mail



- Voters can request a ballot by mail for a single election or they can request to be put on the Permanent Early Voting List (PEVL) and get a ballot for every election they are eligible for.
- To be added to the PEVL MCED must have a signature to verify against the voter's registration.


Casting ballot independently

- Every early voting site & each polling place on Election Day in Maricopa County is equipped with a touch screen voting machine for voters to use in order to vote independently.
- AZ law requires a paper audit trail.
- There is audio available in
 - English
 - Spanish
 - Tohono O'odham
- There is standard & large print
 - English
 - Spanish



Privacy

- Each transaction has a paper record which is reconciled and can be audited.
- The paper advances so the next voter does not see how you voted.
- Each voter using the touch screen has their ballot style programmed on a Voter Card.
- The card can only be used once before it has to be reprogrammed, a voter cannot use it to cast more than one ballot.



Assistance Options



- You have the right to assistance by the person of your choosing to help you vote at the polls.
- There are only 2 restrictions:
 - Cannot be your employer or union representative (federal law)
 - Cannot be a candidate on the ballot (state law)
- You have the right to assistance by poll workers at the polls on Election Day.
- You have the right to request special assistance in voting at home if you are unable to go to the polls, an early voting site, or are unable to complete the ballot yourself.

Special Election Boards (SEB)

- Voters who are in a care facility, nursing home, or are homebound and do not have anyone to assist them in voting an early ballot can request an SEB team to help them.
- MCED coordinates with facility directors and administrators to schedule visits and ensure that all voters get the assistance that they need in an impartial manner.



Special Election Boards

- This assistance is for those voters who truly NEED it.
- We once got to a home to provide assistance only to find a note tacked on the door that the voter would be back shortly—they were playing golf and got an earlier tee time than they expected!


Second Chance Voting

- What exactly is it???
 - If you mark your ballot and over-vote an office or mark it in such a way that your vote is not read the tabulation equipment used at the polls and the boardworkers need to notify you and allow you the opportunity to rectify your ballot.
 - This is common when voters mark both yes and no on the judge retention portion of the ballot.
 - When that happens the tabulation machine will kick the ballot out and you have the option to have that ballot accepted and counted as it is, or to spoil the ballot and cast another.

Second Chance Voting

- If the voter decides to leave the ballot and cast it as marked *all other races and questions on the ballot will be counted.*
- It is simply placed back into the machine, which will kick it back, and the boardworker can override at the request of the voter so that the rest of the ballot is counted.

It is the voter's right to decide if they spoil the ballot and vote another or cast it as voted.



- If the voter decides that they want to correct the error on the ballot they have the right to spoil the ballot and get another.
- Voters may only have one ballot in their possession at any given time, they may not use the first ballot to aid in marking the second.
- Voters may only have up to 3 ballots.


Why do polling places change?

- Polling places can change for a variety of reasons and can change up, to and sometimes including, Election Day.
 - Management can deny our use of their facility
 - Voters can recommend a different location
 - Type of election being held
 - Facilities can be under construction or closed
 - Voting precinct lines can change
 - Size of the facility has to accommodate growth in voter registration &/or anticipated turnout
 - Polling places are determined by the entity holding the election (MCED, City, School District, etc.)


Know what is expected at the polls

ID is Required

- Voters can provide either One (1) photo ID off of List 1, or two (2) non-photo IDs off of List 2 to get a standard ballot.
- Voters can also combine from Lists 1 & 2 to vote a standard ballot if the address on List 2 ID matches the way they are registered.
- If the address on the ID is not the same as the voter's registration they will be asked to vote a provisional ballot—***THEY DO NOT HAVE TO RETURN WITH ANY OTHER ID***
- If the voter does not have sufficient ID they can vote a provisional ballot which is conditional upon them returning with ID either to the polls on Election Day or to an ID verification site post election.
- ***It is the voter's right to decide how they want to proceed and what ID they present from List 1 &/or List 2.***


Insufficient ID or no ID at all:

- If the voter has insufficient identification or no ID, the voter can go home and get ID, return to the polling place before 7 PM, and vote a Standard Ballot:


- Or the voter can vote a Provisional Ballot, but identification will still be necessary in order for the ballot to be processed.
- The voter can go home, get ID, and return to the polling place while the polls are open:



A form is filled out to show that the voter returned with ID so that their Provisional Ballot can be processed. The form will be deposited in the Provisional Ballot box.

Insufficient ID or no ID at all:

- If the voter does not return to the polls, they can provide sufficient ID for the 3 days following a Jurisdictional or Primary Election or 5 days following a Federal General Election.

Campaigning at the polls

- As we mentioned, voters can bring materials to aid them in casting their ballot but are not allowed to use those materials to campaign inside the 75 foot limit.
- Additionally, political party observers in the polling place and the poll workers themselves are not allowed to express any personal opinion or espouse any political views while in the 75 foot limit.
- ***It is your right as a voter to vote in a quiet and respectful environment.***


Campaigning at the polls

- Many candidates and political action committees will take advantage of so many active voters in one place, at one time, and gather petitions on Election Day at the polls.
- They too must stay outside of the 75 foot limit and not hinder access to the polls



Non-electioneering sites

- It is Arizona law that the polling places which are chosen allow for electioneering (unless no other site is available or a site must be obtained in an emergency).
- For each election the select few sites which do not allow electioneering are posted on our website.
- Most polling locations allow for electioneering but some may restrict areas where signage can be posted.



RIGHT TO VOTE A PROVISIONAL BALLOT

You have a right to vote a provisional ballot if one of the following situations applies to you:

- if your name does not appear on the precinct register, and you are in the correct polling place,
- if you have moved to a new address within the county and have not updated your voter registration,
- if you have legally changed your name and have not updated your voter registration,
- if you requested an early ballot but did not vote an early ballot,
- if you have not produced sufficient identification,

- if you were challenged as a qualified voter.

To vote using a provisional ballot:

- present to the election officer an identification stating your given name and surname,
- present to the election officer your complete residence address, or
- sign an affirmation on the provisional ballot envelope stating that the information filled out on the provisional ballot envelope is correct, that he/she resides in the precinct, that he/she is eligible to vote in this election and that he/she has not previously voted in this election.

If you vote using a provisional ballot, the election official will enter your name on the signature roster. You will be asked to provide your signature next to your name.

Once you have voted using a provisional ballot, your ballot will be placed in a provisional ballot envelope, which you can seal. The election official will ensure that the envelope is sealed. You will then be given a provisional ballot receipt with information on how to present sufficient identification to the county recorder if necessary, and how to verify the status of your provisional ballot.

Provisional Ballots

- Not only do you have the right to vote a provisional ballot, but you have the right to know if that ballot was counted or not, and why.
- When you vote a provisional ballot you are given a pink receipt which contains a unique affidavit number on it which corresponds to the provisional form attached to your ballot envelope.
- This receipt provides instructions on where to obtain the status of your provisional ballot after the election.

- They run the same report election morning to be sure that the machine has not been tampered with over night.







The STEP-UP Program seeks to involve the next generation in the democratic process prior to registering to vote. This program allows students who are at least 16 years-old to work at polling places on Election Day as full-fledge workers with all of the responsibilities and rewards. It is hoped that by having a real-life rewarding Election Day experience students will develop a life-long tradition of civic responsibility, both as poll workers and voters.

Requirements:

To qualify for the STEP UP program, a student must:

- be at least 16 years-old,
- a U.S. citizen,
- submit an application that includes parental permission
- attend training.

- Training Class: \$10
- Set-Up Meeting: \$5

In 2006, A.R.S 16-531G was passed, which allows students at least 16 years of age to work at the polls on Election Day. The Statute is listed below:

G. Notwithstanding any other law, the board of supervisors may appoint to an election board to serve as a clerk of election a person who is not eligible to vote if all of the following conditions are met:

1. The person is a minor who will be at least sixteen years of age at the time of the election for which the person is named to the election board.
2. The person is a citizen of the United States at the time of the election for which the person is named to the election board.
3. The person is supervised by an adult who has been trained as an elections officer.
4. The person has received training provided by the officer in charge of elections.
5. The parent or guardian of the person has provided written permission for the person to serve.
